## UGANDA ROADWORTHINESS INSPECTION TARIFF 2009

This tariff is effective from 13<sup>th</sup> OCTOBER 2009.

MOTOR VEHICLES: motorcycles, small vehicles, passenger vehicles, commercial, multi-purpose vehicles (includes trucks and buses).

**Fee: JPY 13,625 per unit**

INSPECTION FEE:	JPY 11,325 (inclusive of 5% consumption tax) per unit
UNBS ADMINISTRATION FEE:	JPY 2,300 (exclusive of consumption tax) per unit

Re-inspection Fees:

① Re-inspected within 14 days after the original inspection (including Sat. & Sun., excluding Holidays):	Free
② Re-inspected after 15 days and within 1 month of original inspection including Sat. & Sun. (exclude Holidays):	JPY 5,650 (inclusive of 5% consumption tax) per unit
③ After 1 month of original inspection:	JPY 11,325 (inclusive of 5% consumption tax) per unit
④ Vehicle failed more than two times regardless of the above term:	JPY 11,325 (inclusive of 5% consumption tax) per unit
